PRELIMINARY & FINAL REGISTRATION

All entries, accommodation reservations, transport needs, flight arrival/departure information and visa invitation letter requests are to be completed using WAREOS.

The World Archery Online Registration System (WAREOS): <http://register.worldarchery.sport> now handles the entire registration process for this event. No entry forms, hotel reservations or transport forms will be accepted; all information is to be entered into WAREOS.

Member Associations can log in to WAREOS at <http://register.worldarchery.sport> with your Username and Password assigned by World Archery. After entering WAREOS, please find the event from the list, you wish to register your athletes. Select/press the “Entries” button to see the list of categories in the event. Select/press the “category” to enter the athlete and official numbers/details participating for that event. A *WAREOS User Manual* can be downloaded in PDF format (English) upon login.

A maximum number of **three (3) athletes per country** (host country included) is allowed to be registered into each category of the event. Preliminary entries have to be completed using WAREOS.

Please respect the stated deadlines.

Member Associations can only use WAREOS to make any changes/amendments to their entries and will be able to do so at any time. An email will be automatically sent to the Organizing Committee and Member Association with the updated information in WAREOS.

Any changes that are made after the deadlines specified or if entries differ by more than 2 athletes from the preliminary entries, the following penalty fees will automatically be applied.

NOTE: CHF currency exchange rates will be those on the date of the event.

Member Associations that have penalty fees outstanding from 2020 will need to have paid these penalty fees before being eligible to enter and compete.

Any entries received less than 3 days before the team managers meeting for the World Championships will be refused if no preliminary entry and/or final entry are made prior. This decision cannot be appealed by the teams and is fully compliant with the current World Archery rules, article 3.7.1.2. Entries received after the deadlines, are subject to penalties as clearly stated in the rule book and the invitation documents of the World Championships. A Member Association that has made final entries in WAREOS and does not participate will be invoiced for the number of entries entered in the system, unless they have informed World Archery and the Organizing Committee in writing at least one week prior to the event that they are unable to attend.

ACCOMMODATION & GENERAL INFORMATION

Due to logistics of hotels and COVID-19, you will register for the room rate and number of nights you will be stay. You will NOT choose the exact hotel. Exact hotels will be assigned after the preliminary entry deadline.

The official hotels in Yankton are Best Western/Kelly Inn, Econolodge, Holiday Inn Express, Lewis & Clark Resort. In Vermillion – Red Roof Inn & Best Western Vermillion Inn. Due to limited capacity a “First Come, First Serve” policy will be followed. All hotels are on the shuttle route. The accommodation cost will include breakfast and lunch. Dinner will be provided each night at the NFAA Easton Yankton Archery Center for an additional cost. If teams don’t purchase the dinner option, they will be responsible for own meals and evening transportation to meals.

Teams who do not reserve their accommodation through the organizing committee will be charged a double entry fee.

- Reservations should be made on or before **01 August 2021**
- Final Hotel Reservation & Transportation on or before **31 August 2021**

To confirm the reservation, a 60% deposit of the total amount is required to be bank transferred to the LOC on or before **01 August 2021**. Reservations after this date will be considered only according to availability.

IMPORTANT!

DUE TO LOGISTICS OF HOTELS & COVID-19 - Please, note that there will be a limited number of rooms at each hotel. **Please book your hotel as soon as possible.** Reservations are only final after the LOC has received the deposit of 60%. Due to limited capacity a ‘First Come, First Serve’ policy will be followed. According to the availability of the rooms, the LOC reserves the right to direct the teams to the hotels of the same level. Most hotels do not have a restaurant, but dinner option is available each evening at the NFAA Easton Yankton Archery Center.

The hotel room rates are per room, per night, including Wi-Fi, breakfast at the hotels, lunch at the venues and local transportation.

In addition, the LOC will not be responsible to provide event information to any hotel not on the official accommodation list.

Teams that book non-official accommodation will need to register at the accreditation desk no later than the day before official practice day. Failing to do so will result in no changes being made to the entry list and it is likely that participation in the event will be refused if registration is not completed in time.

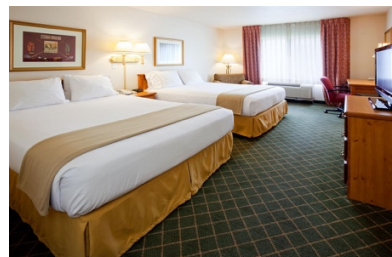

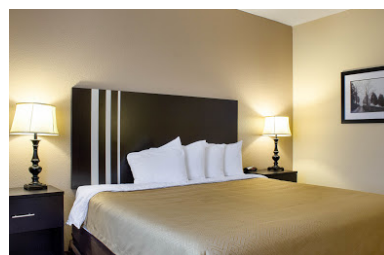

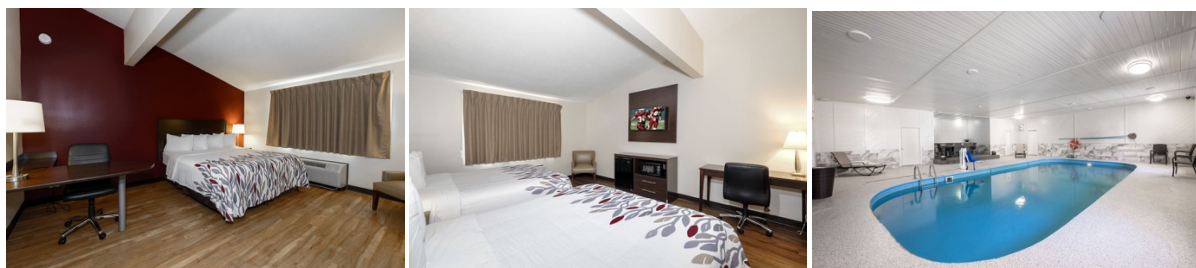

There is no entry fee for teams.

Entry fees include daily local transport to and from the practice field to/from official hotels during the qualification, elimination and finals venues (timetable to be confirmed on site).

*VIP ACCESS – Must be approved by LOC before credentials are issued. Examples of VIP's include Presidents of Federations, Secretary General, World Archery Officers, etc. VIP credentials provide access to VIP area at finals venue and specialized transportation. Please note - transportation is not available from non-official hotels.

PAYMENT CONDITIONS:

The entry fees should be paid in full before arrival.

To confirm hotel reservations, a minimum 60% deposit of the total amount is required to be bank transferred to the LOC on or before 1 August 2021. Reservations after this date will be considered only according to availability. The final outstanding balance shall be made via bank transfer before arrival. Accommodation cannot be guaranteed after this deadline. A balanced invoice will be provided via WAREOS.

HEALTH REGULATIONS (COVID-19)

INFORMATION:

- Everybody should follow the Government/public health authorities measures (national and sport-specific regulations) and be aware of the travel restrictions.
- For your information, Medical Infrastructure/Hospital with proper care will be reachable within 10 minutes from venue, where COVID-19 test can be done.

PERSONAL HYGIENE AND HEALTH ADVICE:

- Anyone due to participate in the event who is feeling ill should not attend.
- Participants (athlete, volunteer, official, etc.) should proactively and regularly check their health status (including taking their temperature and monitoring for any symptoms).
- Stay home and self-isolate even with minor symptoms for 10 days or more depending on national protocols, when showing any symptoms (fever, tiredness, dry cough, headache, nasal congestion, runny nose, sore throat, difficulty breathing).
- Contact a healthcare provider immediately if any respiratory illness is noted.
- Masks to be worn at all times everywhere (transport, common area in the hotel, venue, training, etc.) except on shooting line.
- Regularly and thoroughly clean your hands with an alcohol-based hand rub or wash them with soap and water.
- Avoid touching eyes, nose and mouth.
- Cover your mouth and nose with your bent elbow or tissue when you cough or sneeze. Then dispose of the used tissue immediately and wash your hands.
- Avoid touching high-contact surfaces such as door handles, walls or windows, etc.
- Avoid going to crowded places.
- Avoid steam rooms and saunas.
- No spitting, as the main mode of transmission of the virus is in respiratory secretions.
- No handshakes, high fives and any other personal contact.
- Athletes should not share clothes, bar soap, sports equipment, water bottles or other personal items.

TRANSPORT & VENUE:

- Avoid using public transport to go to the hotel and between the hotel and the venue.

VENUE:

- Access to the venue might be denied at any time in case of disease suspicion
- Limit contact/interactions
- Handwashing/alcohol – based hand gel will be available at multiple locations in the event facility and accommodation.
- Regular toilet cleaning will be done (at least once per session).
- Tissues and containers will be at disposal to dispose of used tissues on transport to venue, at the venue and any other facility.

- No shows allowed. Winners will receive their medals in a simple ceremony only with the winners and their team, all wearing masks.
- Medical post and designated personnel on site able to help assess cases and potential other illness will be present.
- An isolation room/space to hold any symptomatic person found at the venue will be available.
- Space on shooting line shall be 1.00 meter minimum per athlete.
- No spectators are allowed during the event.

PARTICIPANTS:

- Maintain the staff/team to a minimum to minimize transmission.
- Maintain social distancing, at least 6 feet / 2 meters distance between yourself and others at all times.

COVID-19 TESTING:

COVID-19 testing, PCR test with travel certificate, will be available for participants prior to departure home. Expense for tests will be added closer to the event. All expenses are the responsibility of the participant and shall be booked through WAREOS in the “Extras” section.

ADDITIONAL INFORMATION

Transportation

Transportation will be provided from the two official airports:

Joe Foss Regional Airport in Sioux Falls, SD (FSD) 80 mi / 130 km from the venue to the official hotels, two days before the official practice day and one day after the closing day.

Eppley Airfield in Omaha, NE (OMA) 156 mi / 251 km from the venue to the official hotels, two days before the official practice day and one day after the closing day

The cost of this service is \$25 USD per person one way to/from Sioux Falls Airport and \$35 USD per person one way to/from Omaha Airport.

Local transport will be available between official hotels and archery venues. Transport timetables will be confirmed at a closer date from the event. Buses and/or vans will be provided.

Lunch at the venues

Lunch is included in hotel charge. Those signed up through official hotels will be provided a warm lunch at the NFAA Easton Yankton Archery Center.

Dinner

At an additional cost, teams can sign up for dinner service which will take place each evening at the NFAA Easton Yankton Archery Center. To order this option, teams should do so in advance on extra section in WAREOS. Charge each night for dinner at the center will be \$20.00 per person. Teams that don't sign up for dinner service at the complex will be responsible for their own meals and evening transportation to and from meals.

Training

A training field will be available starting 16 September 2021. The training facility is at the NFAA Easton Yankton Archery Center. Teams who wish to arrive and practice earlier than this date may add this in the extra section in WAREOS. Prior to 16 September 2021, a fee of 10.00 USD per day/per person will be charged and individuals will have access to both the indoor and outdoor facilities.

Weather

According to weather information, the average temperature in September is expected to be 60 to 80°F / 15 to 27°C. Average sunrise is 7:10 AM. Average sunset is 7:20 PM.

IMPORTANT INFORMATION REGARDING VISAS

Applying for a travel visa to the United States is the sole responsibility of the participating teams. A visa is required for all visitors to enter the United States except for citizens of Canada and the 38 nations who are eligible for the "Visa Waiver Program." To obtain a visa each individual must apply through a U.S. Embassy or Consulate. This process MUST be done by the applicant – the organizing committee cannot do it for you!

All participants are required to complete the Visa Support sections in WAREOS by no later than 01 August 2021.

As part of COVID-19 mitigation efforts, the United States has restricted the entry of foreign nationals to the US where a person has had a physical presence in a restricted country in the 14 days before arriving in the US. A foreign national in this category will require a National Interest Exemption (NIE). For a current list of countries please go to www.yankton2021.org/visas. Please note, the NIE is required for ANYONE who has traveled through one of the restricted countries. Restrictions are not based on citizenship, but physical presence.

It is the applicants' responsibility to supply the necessary information, and to ensure all details are up to date, correct, and submitted by the deadlines specified.

In addition, all participants that require a visa are requested to supply a copy of a valid passport. Copies of each application can be uploaded on WAREOS. All passport copies and personal details entered/uploaded to WAREOS will be held securely and in the strictest of confidence.

Please note, the Organizing Committee can only provide invitation letters for the period of the Hyundai World Archery Championships in the United States.

Yankton, South Dakota is the home of National Field Archery Association Foundation, and the first of the Easton Foundations Archery Centers. Situated on over 130 acres; the NFAA Easton Yankton Archery Center includes three outdoor field ranges, a 3D range, two FITA ranges, two 90m indoor ranges, two classrooms, a fitness studio, and the NFAA Foundation Archery Museum.

Easton Field and First Dakota Field are 90-meter grass fields with room for a combined 130 targets and 260 shooting lanes. Awnings cover the entire width of the ranges, providing shade for the archers between ends, and a lawn behind the shooting line allows for spectators.
